Background

Deans & Associates (1993) Limited, (“the Company”) ceased trading in 2015 due to a restructure of ownership of the Company. The Company is solvent and is being placed into solvent liquidation for the purpose of restructuring the shareholders’ affairs; it has always the intention of the director/shareholders to liquidate the entity.

The timing of the liquidation has now been prompted by proceedings served on the Company on 29 March 2017.

The Company was unaware that there was ever any intention for these proceedings to be filed and vehemently deny any liability in these proceedings. As a consequence of the liquidation, these proceedings are stayed and the liquidators do not propose to take any action on these proceedings.

Proposals for conducting the liquidation

The liquidators will complete a final report and request that the Registrar of Companies remove the Company from the register.

Meeting of Creditors

In accordance with Section 243(8) of the Companies Act 1993, there is no requirement for a creditors meeting where the company is solvent. If, however, there are any creditors with queries or concerns, they may contact the liquidator at any time.

Pursuant to Section 314 of the Companies Act 1993, a creditor or shareholder may, at any time in the course of the liquidation, request that the liquidator call a meeting for the purpose of appointing a liquidation committee. This request must be in writing.

Estimated Date of Completion

It is not practicable to estimate the date of completion of the liquidation at this stage.
